6 month cycle

March

Applications received

501c3, school, government status review

September

completion & criteria review

grant committee review & scoring

grant committee selection meeting

grant report board approval

award/denial emails sent out

April

October

May

signed terms & conditions forms due

November

payment request form w/receipts due

email final grant report

check presentation/pictures when possible

October

April

Request an extension via email for any projects that is not completed in 6 months.

JCCF, Inc. will allow one extension of 6 months applied to grant allocations.

- *Grant request from individuals are not accepted.*
- *Must contact the foundation prior to submitting a request of \$10,000 or more.*
- *JCCF, Inc. CANNOT write checks to individuals for grant support or scholarship awards.*

grants range from: \$1,000 to \$10,000



True Intent of our Fund Holders

We are a grant maker. We make grants possible through the philanthropy of our endowments established by fund holders. These funds have criteria's or a true intent. Our applicant's must meet those requirements to qualify for their support. Grant support is based on the funds spending level. Note: In recent year's nonprofits have experienced a 50% increase in the cost of projects & program support.

GRANT ELIGIBILITY

To be eligible you must be one of the following:

- ✓ private, nonprofit organization tax-exempt under section 501(c)(3) of the IRS code.
- ✓ public institution, such as public school or government entities that serve the municipalities of Jackson County, WV like libraries, police & fire departments, community centers, and shelters.
- ✓ JCCF, Inc. 501(c)(3) Agency fund holders can receive grant checks directly to their program. Other clubs or groups that are not 501(c)(3) but are fund holders can receive grant support under the foundation's umbrella. Checks are distributed to the fund administered by JCCF, Inc.

Capital and Equipment Grants

renovation or construction of **PUBLIC** facilities or centers
(Does not include privately owned businesses or churches).

purchase of major equipment, major repairs to facilities for a field of interest or cause that assist the **PUBLIC** like food distribution centers or shelters for housing & rehabilitation purposes.

Program Development Grants

support the development of new services or programs designed to respond to unmet community needs and the expansion of existing programs to serve new audiences;

Operating Support Grants

only for organizations with 501(c)(3) status

support is considered. priority is giving to projects designed to increase financial stability; and help strong organizations increase capacity.

Must be a 501(c)(3) nonprofit organization (operating support is not available to governmental entities, schools (public or private), or entities that do not have 501(c)(3) status.

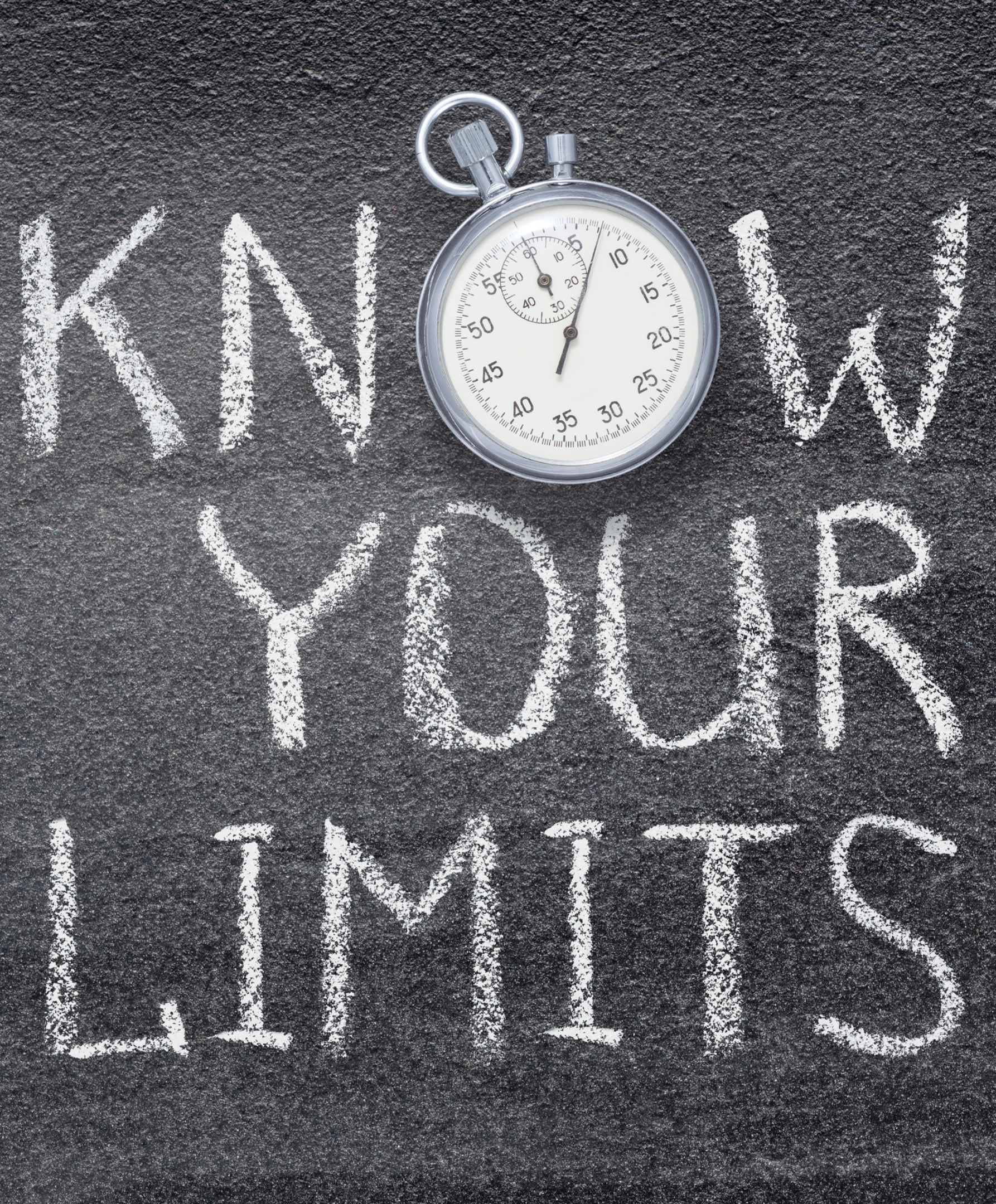


Make a Grant Folder

Have quick access to:

Check List

- ☐ Directory of Officers-Board of Directors, or Trustees including their titles & contact information.
- ☐ Financial Report-Most recently completed fiscal year, showing income and expenses (preferably audited)
- ☐ IRS 501(c)(3) Designation Letter-(Not required for government agencies and public schools)
- ☐ 990 or 990N-Only 501(c)(3), Most recently tax return or postcard.
- ☐ Operating Budget-Current annual organizational income and expenses.
- ☐ Project Budget-complete the printable form provided, add pictures, estimates, and invoices. Scan all documents and upload to application.



Grants will NOT be made for:

annual campaigns; endowments;

sectarian religious purposes;

political purposes or lobbying activities;

retiring existing obligations, debts, or liabilities;

student travel or student participation in meetings, seminars, or study exchange programs.

Public school projects MUST

be approved by the Board of Education, contact Lora Matheny. Application/financials must be signed by school principal.

Playground equipment grants are limited to \$1,000

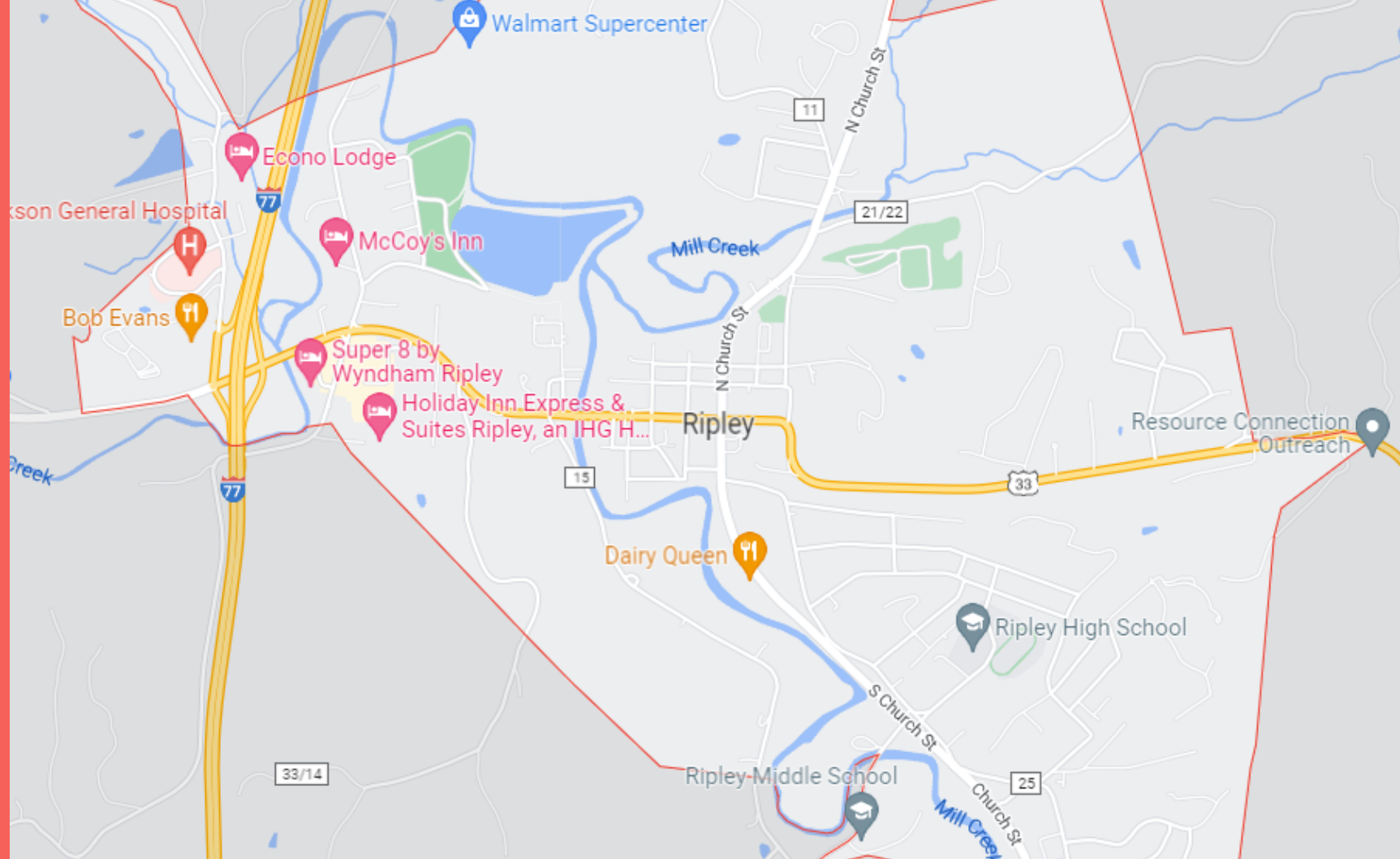
